- a. **Social Media (website/Facebook)-Hall** – Need to update website with upcoming meeting dates. Will approve the calendar at this meeting during new business.
- b. **Spirit Wear-Finnigan** – Mary has a stock of spiritwear shirts, to be on sale soon.
- c. **Banner Ads-DeVlaminck** – Received renewals from: Masters Automotive, Dryden Dental, Paul's Collision, Advance Scraping. Still looking at possibility of having ads in gym. Local school (Oakland Christian) has a framed sign that smaller banner ads slide into. Loraine to contact school for picture and possible fee structure.
